Myanmar is fast becoming one of the hottest destinations for investments into ASEAN, aided by the rapid developments in infrastructure and continuous refinement of government policies to attract the international business community. The 2011/12 GDP of Myanmar is estimated at US\$89 billion with growth of 5.9% which reveals an improvement from the GDP of US\$82.7 billion and an annual rate of 5.5% recorded for 2010/11. The economy of Myanmar grew by 6.5% in 2012/13 and is expected to expand by 6.8% in 2013/14.

Located within the FMI Centre, our Myanmar office operating with local professional staff is headed by two of our directors who possess a good knowledge of local business practices, given their experience in serving Myanmar based public listed clients.
